

Certification & Ongoing Support

Certification to a management system varies between standards an certification bodies but the overall process is standardized. The certification requires an a management system with at least 3-6 months of compliant records including the Internal Audit an Review. The certification will Management generally start with a Stage 1 Audit often called a readiness review or document review. Generally about a 3-6 weeks later the Stage 2 audit will review all the operations of the company and dig deep into the requirements of the management system. Any findings will be issued during Stage 2 and a response will generally be required within 30-60 days to these findings for review by your auditor. Once these findings are resolved, you're ready to receive certification under the rules and requirements of the specific certification body.

1 Stage 1 Audit

Stage 1 is effectively a checklist. This stage is essential for the auditor to see if the organization meets the minimum requirements to be certified.

Stage 2 Audit

At this stage, the documentation you presented in stage 1 must conform to what the auditor is seeing in the stage 2 audit.

3 Surveillance Audit 1 & 2

Annual partial audits against the requirements of the standard. There will be Surveillance 1 and Surveillance 2 audits prior to recertification the following year.





Recertification Audit

Similar to the initial Stage 1 and Stage 2 Audits, the recertification audit is a complete audit against all requirements of the standard.
